#### **Learning Outcome 5:**

Demonstrate an understanding of how effective waste management and processes can impact and reduce the production of Carbon Dioxide and other greenhouse gases.

Identify what we mean by greenhouse gases and consider the impact	Questions, research and surveys

Identify the correlation between waste products and the 5 principles within the "Waste Hierarchy"	
Research and identify signage and waste bin apertures used internally and externally, the waste they represent and if waste collection could be improved	
Compare how we dispose of waste products using two different waste systems, the CO 2 produced from each system and identify 1 commodity that can be produced by the correct system	
Describe how a landfill site is created, the preparation required before waste can be deposited and how we restore them when full
